## Cookie and personal data policy

### What do we store about your visit to our website?

Relay Trust does not store information about your use of our website and cookies are not used (a small text file stored in your browser to recognize your computer on subsequent visits). If changes are made, it will be published in our privacy policy and shared with users, who will be invited to accept the changes.

### What information do we store about you?

If you have subscribed to our newsletter, we will record the following information about you:

1. Your name (first name and last name) - note: it is not necessary to provide both first and last name.
2. Your email address
3. Your registration

The information is not shared with third parties.

All recipients of newsletters have access to change the information themselves.

If you choose to unsubscribe from the newsletter, your information will be deleted as soon as possible and no later than one month after you have unsubscribed.

Your personal information is registered because you have previously registered that you want to receive newsletters from Relay Trust (either by online registration at [relaytrust.dk/relaytrust.org](http://relaytrust.dk/relaytrust.org) or in writing). Your name (either first name, last name or both) and your email address are required for us to provide you with our newsletters.

### Members of Relay Trust DK

If you are a member of Relay Trust DK, we will register the following information about you:

1. Name
2. Surname
3. Address
4. Telephone
5. Email
6. Transfer details from our bank

Information about members is not shared with third parties.

For the sake of our membership archive and registration, we need your full name (first name and last name). Although Relay Trust DK primarily communicates with its members via email, we keep phone number and address so that we can always get in touch with members.
